We are seeking an enthusiastic and dedicated Marine Project Officer to join our team, focusing on marine conservation and community engagement. This role offers an excellent opportunity to work on seagrass and marine mammal monitoring, promoting environmental awareness, and engaging with local communities. If you're passionate about marine conservation, possess strong communication skills, and are adept at using creative and digital tools, we want to hear from you!

The role requires excellent communication skills in both Welsh and English, along with confidence in organising and delivering public events. Technical skills for hosting online events and managing social media related to the projects are also essential. Having a passion for marine mammals and seagrass is beneficial, although individuals will receive assistance and training to acquire the essential marine knowledge and skills required for the role, such as survey techniques and species familiarity. You will be part of the Special Area Conservation (SAC) team at Cyngor Gwynedd, collaborating closely with other community projects such as Natur am Byth. Although based on mainland Pen Llŷn and Ynys Môn, the job will involve regular visits to Ynys Enlli, including occasional overnight stays.

This post offers a unique opportunity to work in a remarkable area, engaging with marine mammals and seagrass while contributing to the conservation of protected sites and species. We're looking for someone who can work independently, yet be a team player, all working towards positive conservation outcomes in this exceptional marine environment.





The Marine Project Officer will focus on community engagement for two projects:

## Enlli marine mammal project - connecting people with the sea

The project is hosted by the Bardsey Bird and Field Observatory (BBFO) (www.bbfo.org.uk) and will be based within Cyngor Gwynedd, with work centred on Pen Llŷn. Ynys Enlli is situated in a crucial area for marine mammals, surrounded by the West Wales Marine Special Area of Conservation (SAC), designated for harbour porpoises, and the Pen Llŷn a'r Sarnau SAC for which bottlenose dolphins and grey seals are features. Additionally, grey seals are a feature of the National Nature Reserve designation. Risso's dolphins are also regularly seen in the area and have been the subject of long-term studies by organisations such as Whale and Dolphin Conservation, in collaboration with BBFO.

Recently, the seas in this area have been internationally designated as an Important Marine Mammal Area. This designation recognizes the presence of harbour porpoise, bottlenose dolphins, risso's dolphins, minke whales, common dolphins, and seals.

This project is funded by the Nature Networks Programme and delivered by the Heritage Fund on behalf of the Welsh Government.

The Marine Project Officer key roles will include:

- 1. Raising awareness of the importance of the waters around Pen Llŷn for marine mammals, their conservation needs and promoting adherence to the Gwynedd Marine Code.
- 2. Recruiting and, working with the Project Manager, train volunteers to undertake dolphin surveys from key points on Pen Llŷn.



## Seagrass Ocean Rescue - reconnecting people with nature and restoring seagrass through reseeding

Seagrasses are the unsung heroes of our coastal seas. With up to 92% of the UK's seagrass lost, restoring it is vital for ocean health. Seagrass offers numerous benefits: it protects coasts, improves water filtration, stores carbon, supports fisheries and biodiversity and helps fight climate change.

Seagrass Ocean Rescue, a partnership involving Pen Llŷn a'r Sarnau SAC, WWF, Project Seagrass, Swansea University, and the North Wales Wildlife Trust, plans to reseed seagrass over an area of 10ha across Pen Llŷn and Ynys Môn in collaboration with local communities.

The Marine Project Officers key roles will include:

- 1. Community engagement and education
- 2. Creation of promotional material and creative projects
- 3. Develop digital content
- 4. Plan and run community and volunteer events

This project is funded by the National Lottery Heritage Fund.



## **Job Description**

#### **PURPOSE OF THE POST**

- Develop, monitor and help implement projects derived from the SAC's Management Plan.
- Organise events and take part in promoting and raising awareness of the SAC.
- Support delivery and updating of the SAC's Management Plan.
- Ensure that the people of Gwynedd are at the heart of everything we do.

## **RESPONSIBILITY FOR RESOURCES (e.g. staff, budgets, equipment)**

- Responsible for any equipment provided for the purpose of the post, including computer, laptop and phone.
- Responsible for occasional volunteers and individuals on work experience.
- Oversee the work of contractors.

- Promote and support communication between management groups, any groups that are set up under projects, existing groups, stakeholders and the wider public.
- Assist the Line Manager with managing budgets and maintaining accurate financial records.
- Keep detailed records of expenditure and the project's development and report on outputs to the Line Manager.
- Work with the Line Manager to develop a communication strategy for the project.

- Promote the value of the local marine environment amongst the local community, including updating social media platforms and the website.
- Identify new funding opportunities to enable the continued growth of the work.
- Responsible for self-development.
- Ensure compliance with workplace Health and Safety rules in accordance with the responsibilities set out in the Health and Safety at Work Act 1974 and the Council's Health and Safety Policy.
- Act within the Council's policies in relation to equal opportunities and equality.
- Responsibility for information management in accordance with the Council's information management standards and guidelines. Ensure personal information is handled in compliance with Data Protection legislation.
